Corrective Action: Non-food contact surfaces of equipment that are exposed to splash, spillage, or other foods that require frequent cleaning shall be constructed of a corrosion-resistant, nonabsorbent, and smooth material.</p> <p><b>49</b>  <b>4-602.13 - Nonfood-Contact Surfaces Kept Clean</b>            Observation: The nonfood-contact surfaces of the following equipment had accumulations of grime and debris: filters from the ventilation hood systems needs cleaning.            Corrective Action: Nonfood-contact surfaces of equipment and utensils shall be cleaned at a frequency necessary to preclude accumulation of soil residues.</p>
